Welcome and Introduction to 2018 by Rob Crawford – Chairman

Local lettings & sales state of the market, five-minute overview from Andrews – Daniel Mould, presenting a brief update on the state of the local lettings and sales market.

Relief from the recent 'Buy-To-Let' tax changes for UK Landlords - Richard Medley & Neil Miller of Success CXP Ltd. The recent changes to 'Buy-To-Let' tax relief that mean Landlords are no longer able to deduct the cost of mortgages from their rental income. In many cases this change is completely wiping out any profit made leaving many questioning their future within the industry. Success CXP are specialists in asset and profit protection who offer a solution to this change and also offer additional relief from income tax, capital gains tax and inheritance tax for UK Landlords.

National & Local Changes/News - Rob Crawford

What to expect in 2018 and subsequent years:

- The introduction of the new definition of HMO's requiring mandatory licensing.
- Revised minimum EPC rating of E for new lets and renewals of tenancies with effect from 1st April 2018 and for all existing tenancies on 1st April 2020.
- Legislation to ban all fees charged to tenants by landlords or agents in England other than deposits and 'holding' deposits.
- Introduction of HMRC vetting of landlord tax declarations (initially landlords with licensed HMO's).
- Updated Gov'ts "How to Rent Guide" (17 Jan 2018).
- Introduction of the EU General Data Protection Regulation (GDPR) Act
- Tenant's history of rent payments to become a factor in credit histories.
- Introduction of a national landlord redress scheme during 2018/19.
- The government seeks to incentivise landlords in the private rented sector to offer tenants 'family-friendly' three-year tenancies should they wish to.
- The government wants to cap the permitted rental deposit on a property to six weeks.
- The government is keen to see more high-quality rental properties come on to the market by encouraging more competition and choice to 'generation rent'.
- Section 24 of the Finance Act 2015 takes hold, uninformed landlords will be shocked.
- New Bill expected requiring all landlords nationally to register as landlords.
- New Bill "Fitness for Human Habitation and Liability for Housing Standards" (updates the Landlord and Tenant Act 1985 and Building Act 1984).
- B&NES and BCC plan to implement further selective licensing.
- NES consultation on landlord self-regulation and accreditation scheme as an alternative to licensing.
